Westerly storm-force winds batter Halfmoon Bay.

Springtime made a seasonal statement on Sunday 16th November. Storm-force westerlies hammered the Island with local estimates of 50 knots possibly gusting to 70 knots in Halfmoon Bay.

A new house under construction at Lonnekers Bay suffered a significant setback when the newly erected framing was blown over and damaged.

Most other serious damage seems to have been confined to trees, greenhouses and some roofing iron. No damage reports have been received by the Council. South Cape residents encountered 71 knot winds and across the Strait, Puysegur Point reached 66 knots.

Late in the evening of the 1st of November, Paul and Keri-lee faced one of life's most challenging events - a devastating house fire with the very real possibility that their only child, Jahdan, was trapped in the house.

Fire at the Nunnery by Rhys Leask & Fiona Hall. Halfmoon Bay School

On 1st November, at around 10.30pm, Stewart Island had its first major house fire in many years. It almost destroyed the house known as the Nunnery on Kamahi Road. Usually the Oban Volunteer Fire Brigade get the call out quicker, and so get to the scene earlier, but this time the fire had got a good grip.

Tenants Paul Sooalo and Keri-Lee saw Fire Brigade members head up towards their home and decided to follow just in case. "I actually didn't think it would be my house," said Paul.

When he got there he felt shocked, and then

When he got there he felt shocked, and then very, very sad. Paul and Keri-Lee thought that their son Jahdan and good friend John were inside.

Deputy Fire Chief Jed Lewis had the role of driver / pump operator for the big fire truck when the Brigade arrived at the scene of the fire. Mark Donald (Mad) was 'Officer in Charge at the Scene', but he saw that they were short on manpower, and decided to put on protective gear and join the men in the fire. He made Jed 'Officer in Charge' from then on. Jed said it was a stressful time because he thought there were people in the house.

However, the Fire Fighters' training paid off, and they worked efficiently as a team to have the fire under control in five to ten minutes. It was only when the fire was almost out that everyone found out that John and Jahdan were safe at a neighbour's house. They had been unable to telephone from their home, and this had caused the delay in raising the alarm. Jed said, "As soon as it's only a fire, it's a lot easier to deal with". Everyone was very relieved the people were safe.

Paul, Keri-Lee and Jahdan managed to save just a few personal belongings: some antiques, a few clothes, and some jewellery. The thing that has made them feel much better is all the support from the people of Stewart Island. You can't under-estimate the importance of community spirit in this place. A temporary home and all the day-to-day things have been found. The family hopes to stay on the island and are on the lookout for a new home. John has been staying with friends.

When asked how it had changed his life, Paul said, "You don't think it'll happen to you... but it can happen, and so quickly. You have to be so careful about fire." The family had smoke alarms, but had taken them down to replace the batteries. When a house has a fire, any occupants who are sleeping at the time will not be able to smell the smoke as your sense of smell shuts down when sleeping, therefore smoke alarms are essential to wake the occupants in order for them to get out safely.

"It made me think about fire prevention and awareness." In particular Paul recommends ensuring you have smoke alarms up with fresh batteries; make sure you have two escape routes planned from your house and that they do not become blocked; and keep in good contact with your neighbours so that they know your movements.

The many decisions the Fire Brigade had to make on arrival at the fire were compounded by the fact that the information they received on arrival indicated that there were people trapped inside the burning house. No-one was outside the property to meet and advise the Fire Brigade that the people had got out of the house safely (this is the most important information they can get). Every property, especially with children, should have an escape plan and assembly point. (Families with school age children will have made these when the school last ran a fire safety unit). All occupants and baby sitters should be aware of the escape plan and assembly point.

Two days after the fire, the NZ Fire Service Inspector arrived to take stock of things. A report will be published at a later date, and as yet no exact cause of the fire has been established - it could have been caused by a

lot of things. As for the Fire Fighters, Jed says, "It's an important role I don't find hard to do." Here on Stewart Island we rely heavily on the members of the Oban Volunteer Fire Brigade, without whom there would be no-one to put out house fires and save people from serious harm. We should not take them for granted.

We feel privileged to live in a community that cares so much. We live in a special place, made so by the special people who live here.

Book Review by Anon

A Civil Campaign by Lois McMaster Bujold

Available at the local library

I'm a long time fan of Lois Bujold's, and having read the previous books in this series, I find it difficult to judge how it would read to someone coming in, new to the story. If you are new to the series, it would be best to start by reading the timeline given at the back of the book, that gives a brief synopsis of the story so far, BUT - don't let this put you off the book, though!

Lois has won awards for her writing, and this is one of her best, and screamingly funny. She's dedicated it "For Jane, Charlotte, Georgette, and Dorothy – long may they rule" [Austen, Bronte, Heyer and Sayers] and they all are reflected in her work – which is pretty amazing in a hard core, science fiction series. It deals with a soldier, Miles Vorkosigan, whose brilliance, manic energy, and unstoppable determination make him a larger-than-life hero despite his stature -he's 4'10", hunchbacked, and has brittle bones, in a world that is violently allergic to anybody falling outside normal physical appearance.

He's also hyper, a strategic genius, and has a subordination problem. His father is a planetary Viceroy and ex-Prime Minister of Barrayar and his mother is an off-worlder who thinks all Barrayarans are delusional. His homeworld Barrayar is centre of a small and much beset Empire, whose semi-feudalism, rigid codes of honour and lords-and-ladies social pyramid are considered uncouth, almost barbaric, by larger galactic society.

While Miles is an unfailingly likeable viewpoint character, Bujold takes pains to show him also as a near-monster of pushiness and overcompensation who doesn't hesitate to use trump cards of lordly status, charisma, and even the exploitation of his own vulnerability as weapons in personal as well as combat arenas Miles, forced by ill heath to give up his military career and having embarked on a second career as an Imperial Auditor (a kind of wandering judge and ambassador), is madly in love with the beautiful and brilliant Ekaterin Vorsoisson.

The writing is excellent: the books are addicting, fast-paced, and will even make you think: sort of space opera crossed with the psychology of Minette Walters or Elizabeth George.

The book opens with Miles determined to court Ekaterin. Unfortunately, his approach is described as "General Romeo Vorkosigan, the one-man strike force." By his *father*. The potential for comic disaster increases when Miles's clone brother Mark, who was initially produced and raised by terrorists to be a programmed assassin (and still struggling to marshal a "Black Gang" of resulting subpersonalities: Howl, Gorge, Grunt, the suppressed Killer) arrives. He's brought a brilliant but scatterbrained scientist who's created a bug producing a perfect food: bug butter.

They set up a lab in the basement of Vorkosigan House. Mark has also found a nice Barrayaran girl--she even likes the bugs--with whom he got together on the sexually liberated world of Beta. But now Kareen's living at home. Naturally, disaster strikes, repeatedly and on all fronts. The scientist, a fugitive from rough justice on planet Escobar, is developing a dotty but plausible scheme for solving food problems with the delectable exudations of his pet "butter bugs" -- despite a measure of irrational opposition from early tasters revolted by these insects' pustular appearance:

"Bug vomit," said Miles, working through the implications. "You fed me bug vomit." [...]

"It's just like honey" Mark said valiantly, "only different."

Meanwhile, the colossal state marriage of the Barrayaran Emperor Gregor to an outworlder from Komarr is fast approaching, with ripples of tiresome protocol expanding in all directions. "I've seen planetary invasion plans less complex than what's being booted about for this Imperial Wedding." Meanwhile, on woman-starved Barrayar, the hoped availability of widowed Ekaterin provokes a buzz of interest that worries Miles no end. Meanwhile, our hero's friend and rival Lord Ivan Vorpatril is wistfully fancying reunion with one of his old mistresses, an encounter which thanks to Betan biotechnology is an awful shock. Meanwhile certain members of Ekaterin's Barrayaran family feel they could do a far better job of raising her nine-year-old son Nikki. Meanwhile, the rumour that Miles himself was responsible for the death of Ekaterin's unloved husband -- a rumour which like all the best lies has one faint toehold in fact -- is being eagerly milked for political blackmail. Meanwhile, various more or less dirty tricks regarding succession and inheritance are timed to detonate at a climactic session of the Chamber of the Council of the Vor Counts. The Meanwhile list goes on and on...

The subplots, all woven into a whole, come to a shattering climax in the disastrous dinner party it's worth reading the book for this scene alone:

"My dinner party," Miles grated. "It's just breaking up". And sinking. All souls feared lost."

but be warned – you have to read right from the start to catch all the humour! Lois Bujold unfolds her comedy of manners while continuing to explore themes familiar from earlier books: the difficulties in living with physical handicaps, the difficulties in becoming a strong adult woman in a patriarchy, the need for trust and honesty in relationships between the sexes, the difference between appearance and identity, and the impact of advanced biotechnologies on society.

Thanks to all those other Bujold fans on the Net, who helped with the review.

Councillor's Comments

Kerbside recycling is upon us so we're all going to have to get used to being a bit more careful with what we do with our waste. Judging by what's happened in Invercargill, it will be well received, as it makes good sense to separate out what can be recycled. And it really couldn't be made much easier as everyone has a separate recycling bin and a compost bucket

The set up and running costs are covered by the Council's overall waste disposal rate. The Stewart Island Electricity Supply Authority has won the contract to handle the island's recycling and waste disposal, and this will be run as a stand alone operation.

It will not be subsidised through your power account in any way.

Efforts are continuing to get special government funding for improvements to our Island's infrastructure, especially roading and sewerage extensions.

Mayor Frana Cardno is using all her political influence and CEO Michael Ross is great at following up our Mayor's contacts with the facts.

We recently met Chris Carter, the Minister of Local Government and Conservation, with regard to Stewart Island and its requirements, and what we see as the Government's responsibilities. This was endorsed at a meeting between your community board and the Minister.

Some of the issues discussed were the possibility of our roading being declared special purpose roads with a substantial subsidy available, similar to what is being negotiated for the Chatham Islands.

We also asked for confirmation that the sewerage scheme extension had qualified for special subsidies. We have passed every hurdle so far and I trust this subsidy will shortly become a reality.

I would like to think we could get a similar subsidy for a water supply, especially for commercial premises, which have to meet strict health standards.

I am pleased to see the boat park area getting established opposite the community centre. Colleen at the area office informs me there are 12 so far, with the \$250 fee going back to the community.

Finally, the busy season for visitors is nearly upon us again and no doubt many visitors will wander the roadways, forgetting their normal pedestrian responsibilities.

Don't get too frustrated with these casual guests, as they all add to the success of various island-run businesses.

Bin, Bucket and Bags - on their way!



From Monday 24 November residents will see green recycling bins and clear buckets being delivered about town and people going into the Southland District Council Office with a letter and coming out carrying a bundle of bags. What's it all about?

The Council is beginning a new waste collection service. All properties rated for this service will receive one green recycling bin, one clear bucket (with lid) for food scraps and 30 prepaid refuse bags to take residual waste. Collections start on Tuesday 2nd December. All you need to do is put the bin, bucket and bag out on the roadside and they'll be collected (bins and buckets will be returned to the location where they were picked up).



As well, there will be two public drop-off centres. The yellow, green and blue sets of wheelie bins will be located at the end of the wharf (opposite the skip bins – which will be removed) and in the reserve opposite the South Seas Hotel. These bins will be for glass bottles, aluminium cans and plastic 1 & 2 bottles.

All the waste that the Council's contractors collect will be sorted at the new Rakiura Resource Recovery Centre (RRC). You may have seen a flurry of activity there over the last month, as contractors have been busy setting up for the opening. **Everyone** is welcome to attend the official opening of the centre on **Monday 1 December at 11am** - 28 Horseshoe Point Road. Please come along and support the centre.

As the RRC opens the Braggs Bay site will close. To mark the closure, there will be a refuse amnesty from now until 7 December where you can bring any rubbish to the Braggs Bay site for **FREE** during normal opening hours.

"Support the cause" is the message from Brian Cronin (Operations Manager for the RRC).

At the conclusion of the meeting the Chairman made a presentation to Nancy Schofield in recognition of her many years of commitment to the Museum.

Nancy took over as Curator on the retirement of Mrs Eileen Willa in 1986, and held the position until recently when she asked to step down. Her knowledge is one of our greatest assets, and we hope to have it available for many years yet!

Mrs Marjorie Riley, a daughter of Mr & Mrs Ian Gough, presented us with some flags from the **TAMATEA**, which she found while having a clean-up at their crib. Thank you, Marj.

We have also been given some small items of "memorabilia" from Noeline Baker's days at Moturau. These had been in the care of Sheilah Natusch – thank you as well.

"CHAMPION" – this month's boat.

A vessel with a most interesting history, **CHAMPION** was a ships boat on the clipper ship "Champion of the Seas", which was built by Donald Mackay of East Boston in 1854. **CHAMPION** appeared in the south after the clipper called at Port Chalmers in 1863, and she spent a short period as a cargo carrier before she was bought by Coleman Burke, owner of a brewery on the shore of Otago Harbour at a spot now named Burkes-St Leonards. He sailed her as a private yacht, and competed with some success at the Port Chalmers Regattas. She was laid up in 1870, to be sold to the N.Z.Government in 1874 for use as a Customs Dept. Revenue Cutter in the south, under the command of Capt. J.B.Greig. She suffered some damage before being shipped south, and repairs made proved unsatisfactory so in December 1874 she was placed with Tom Leask with instructions

to sheath her in tarred felt and put another layer of planking over it. This proved satisfactory, and **CHAMPION** was then used by Capt. Greig in his work around Foveaux Strait and Stewart Island until he was given command of the **KEKENO** in 1884.

CHAMPION was laid up in the creek at the western end of Maori Beach for a period, and when it came for Capt. Greig to arrange for her sale, she was fairly sodden and Greig placed her once more with Tom Leask. She was repaired and sold by auction "as she lay," on 17th March1885 to Mr L.G.Roope, fetching the sum of 8 pounds -- which after expenses left 4 pounds 15 shillings for the Government!

She was reported missing on 26th August1885 after leaving Papatiki for the islands outside Paterson's Inlet the day before. No trace of her or her crew was ever found apart from a rudder, believed to be hers, found later on Bullers Point.

Well, that's my lot for another month - hope you found something of interest.

For the rest of the community thank you for your ongoing support.



Safety Message - Xmas Tree Lights

In the good old days Xmas Tree lights were supplied via a transformer at 12 Volts and hence very safe. There is a range of very cheap Christmas Tree lights that look like the harmless ones but they plug directly into the mains. Should they get damaged a lethal voltage is present.... I suggest that if you are using this type of light you make sure you use an R.C.D device, especially outdoors. I can supply these for \$40.00. You may be able to get a cheaper variety from any hardware store.

Wildfire

Phillip Smith has recently traded *Volantis*, locally a well-known vessel, for a new hull named *Wildfire*. The *V*olantis was built in the Marlborough Sounds and performed a variety of work in that area including a number of years in Wellington. Phillip purchased *Volantis* in 1985 since when she has been gainfully employed around Stewart Island.

Wildfire was built by Miller and Tunnage of Port Chalmers in 1993 for a Carey's Bay crayfisherman. Originally fitted with two V8 Scania diesels, twin jet units and double pothaulers, she was a real speed machine. However, economy dictated a change. One engine was removed and the hull reconfigured to a conventional keeler with a single prop. The hull is constructed from double, diagonally laid kauri, a layer of ply and then fibre-glassed. This makes the hull very low maintenance and extremely strong.

Phillip is really pleased with his new acquisition. It is ideally equipped for the kiwispotting business, is faster and more comfortable. Many of his clients travel from Europe especially to view kiwi so a high level of service is essential. The trip around Ackers Point to the small jetty in Glory Cove where the party is landed is only undertaken in favourable conditions. Westerlies driving down Pattersons Inlet can make conditions unpleasant, especially on the return trip in darkness. This is where the better facilities aboard *Wildfire* make all the difference.

A Lot of Fuss over Nothing?

A man living in Kandos (near Mudgee) in Australia received a bill for his, as yet, unused gas line stating that he owed \$0.00. He ignored it and threw it away. In April he received another bill and threw that away too.

The following month the gas company sent him a very nasty note stating they were going to cancel his gas line if he didn't send them \$0.00 by return mail. He called them, talked to them, and they said it was a computer error and they would take care of it.

The following month he decided that it was about time that he tried out the troublesome gas line figuring that if there was usage on the account it would put an end to this ridiculous predicament. However, when he went to use the gas, it had been cut off.

He called the Gas Company who apologised for the computer error once again and said that they would take care of it. The next day he got a bill for \$0.00 stating that payment was now overdue. Assuming that having spoken to them the previous day the latest bill was yet another mistake, he ignored it, trusting that the company would be as good as their word and sort the problem out.

- [4] Pay the claimant's court costs; and
- [5] Pay the claimant a total of \$1500 per month for the 5-month period March to July inclusive as compensation for the aggravation they had caused their client to suffer.
